**To Ministry of Finance**

**Press Release JackieO' Mykonos**

**Dear Mr. Staikouras,**

At 01p.m of 30/07/2021, employees of the Public Revenue Investigation and Assurance Service (YEDDE) ATTICA carried out an inspection at the facilities of our company (JACKIE O 'BAR MYKONOS SA) in Plyntri Mykonos. Among other things, they checked the documents issued by our company for the sunbeds on the beach, a place that functions as a place of multiple activities (food, drink) with an electronically accounting program, for which we had already issued the relevant order form for all charges through tax mechanism, which is legally declared and available to the authorities for control.

Despite the fact that the relevant order forms had been issued for these services and would obviously be followed by the issuance of the relevant legal receipt at the departure of the customer (who could remarkably continue to remain in our area for other activities and pay at the end, taking into account the relevant legal proof), this did not prevent the auditors from considering that we had refused to issue the statutory documents but also prejudged that we would not provide relevant receipts at the time of payment.

For this reason, around 13:30 at noon, they issued an act of temporary determination of a fine together with a note of audit findings and an invitation with which they requested for the years 2017-2018-2019, accounting files and documents within 5 days (today and tomorrow is a weekend !!!!). In this false act, in our opinion, where it is stated that we do not issue the necessary tax documents, was included an order to suspend the operation of the company for the next 48 hours, namely, 31/07/2021 & 01/08/2021.

The questions raised by this authoritarian action are many and obviously unanswered; or rather we bring them to the attention of the competent authorities and the public to form a more direct and collective opinion.

Who decides, even though the company has done all the actions required by law that the goal is not to issue relevant receipts / documents? 'In fact, when these actions are already registered in the electronic business system which is directly connected to the tax control mechanism!

What protection is given to any taxpayer when a business is closed so arbitrarily without giving even a small amount of time to explain where and who is wrong? Unless the basic axiom is that auditors have the infallibility and that taxpayers always make mistakes.

The order to seal an entertainment & catering business on the weekend with the highest tourist activity, for 48 hours, abolishes the right - the only one - provided by law for the businessman to go to court and exercise his rights. This may have been the aim of control, to keep our business closed without rights and some without competition (Friday noon we could not exercise any of our legal rights) also the Greek state to lose many significant revenues due to the illegal suspension of our operation.

After apologizing to our customers and friends who had made relevant reservations for 31/07/2021 and 01/08/2021 (Note that the fullness of the business was 100% for the specific period) we would also like to assure them that:

1. We are not going to give in to such unreasonable pressures as we are strictly adhering to the provisions of the tax legislation.
2. We will proceed with the necessary legal actions by appealing to the competent administrative bodies for the annulment of the issued acts which, apart from being extremely damaging, are also particularly defamatory.
3. We will seek by all legal means the redress of any damage we suffered from the treatment we endured so unfairly and without even the right to retaliate.

As for us personally, the employees, executives, and owners of JackieO 'we promise, that despite the hostile behavior on the part of the state in "Business" and especially under COVID-19 conditions we will continue to strive and offer to our client's high-quality services, according to the law and despite the unjust attacks aimed at impressing and more. We emphasize that since the beginning of the COVID-19 pandemic we have complied with all health protocols exactly as provided by law.
